

COOKIE POLICY

Introduction

When you visit or access our websites or applications, or when you interact with our content ("Services"), we use (and permit third parties to use) web beacons, cookies, pixel tags, scripts, tags, APIs, and other technologies ("Tracking Technologies").

These Tracking Technologies enable us to automatically collect information about you, your online behavior, and your device (such as your computer or mobile device). This helps us enhance your navigation on our Services, improve their performance, and customize your experience. Additionally, we use this information to gather statistics on Service usage, conduct analytics, deliver content tailored to your interests, and provide services to our users, customers, and partners.

We also permit third parties to collect information about you through these Tracking Technologies.

What are cookies?

Cookies are small data files sent from a website to your computer when you visit that site. These files are stored in a folder within your web browser and are not capable of carrying viruses or malware to your device. Since the data in a cookie remains unchanged as it travels between your computer and the website, it cannot affect your computer's operations. Instead, cookies function more like logs, recording user activity and maintaining stateful information. They are updated with each visit to a website. We may access cookies sent by our website to obtain information about you. Different types of cookies track various activities: for instance, session cookies are temporary and are deleted once you leave the site. Storing Tracking Technologies.

We use Tracking Technologies when you visit or access our Services, such as our websites - these are referred to as "First Party Tracking Technologies." Additionally, Tracking Technologies are employed by third parties, such as our analytics service providers and business partners, who run content on our Services - these are known as "Third Party Tracking Technologies."

Both types of Tracking Technologies may be stored for the duration of your visit to our Services or for subsequent visits.



What types of Tracking Technologies do we use?

We use three main types of Tracking Technologies:

- Strictly necessary Tracking Technologies: These Tracking Technologies are essential to enable you to login, navigate around and use the features of our Services, or to provide a service requested by you (such as your username). We do not need to obtain your consent in order to use these Tracking Technologies. These Tracking Technologies can be used for security and integrity reasons for example to detect violation of our policies and for support or security features.
- Functionality Tracking Technologies: These Tracking Technologies allow our Services to remember choices you make (such as your language) and provide enhanced and personalized features. For example, these Tracking Technologies are used for authentication (to remember when you are loggedin) and support other features of our Services.
- Performance Tracking Technologies: These Tracking Technologies collect information about your online activity (for example the duration of your visit on our Services), including behavioural data and content engagement metrics. These Tracking Technologies are used for analytics, research and to perform statistics (based on aggregated information).

- Most web browsers will provide you with some general information about cookies, enable you to see what cookies are stored on your device, allow you to delete them all or on an individual basis, and enable you to block or allow cookies for all websites or individually selected websites. You can also normally turn off third party cookies separately. Please note that the settings offered by a browser or device often only apply to that particular browser or device.
